GemLightbox Warranty One (1) Year Limited Warranty – Worldwide

WARRANTY COVERAGE

GemLightbox's warranty obligations are limited to the terms set forth below: GemLightbox, as defined below, warrants this GemLightbox-branded hardware product against defects in materials and workmanship under normal use for a period of ONE (1) YEAR from the date of retail purchase by the original end-user purchaser ("Warranty Period"). If a hardware defect arises and a valid claim is received within the Warranty Period, at its option, GemLightbox will either (1) repair the hardware defect at no charge, using new or refurbished replacement parts, or (2) exchange the product with a product that is new or which has been manufactured from new or serviceable used parts and is at least functionally equivalent to the original product. GemLightbox may request that you replace defective parts with new or refurbished user-installable parts that GemLightbox provides in fulfilment of its warranty obligation. A replacement product or part, including a user installable part that has been installed in accordance with instructions provided by GemLightbox, assumes the remaining warranty of the original product or ninety (90) days from the date of replacement or repair, whichever provides longer coverage for you. When a product or part is exchanged, any replacement item becomes your property and the replaced item becomes GemLightbox's property. When a refund is given, the product for which the refund is provided must be returned to GemLightbox and becomes GemLightbox's property.
